Concerned Citizens of the Lake Almanor Basin and the Chester Community will present an educational and informative power point presentation before the Plumas County Board of Supervisors on the seeding events taking place in our local air space and their alleged impacts on our community, forests, watersheds, aquatic life, plant life, water quality, and human health.

PG&E SMART METERS & RELAY ANTENNAS ARE BEING INSTALLED IN PLUMAS COUNTY

The Plumas County Board of Supervisors does not have this issue on their May 3rd Agenda. The public is invited to address comments on this program during the Public Comment Period for non-agenda items at 10 A.M. It is time to request that the Plumas County Board of Supervisors immediately declare that this is an "emergency agenda item" and put this issue on their May 3rd agenda. Plumas County should "opt-out" of this program in Plumas County on May 3rd, until public meetings can be held on this issue to discuss health effects and other important issues regarding this program.

It is Illegal to Discard Fluorescent Light Tubes / Lamps in the Trash! "A fluorescent light tube in your dumpster is a violation of the hazardous waste laws. Violation of these laws can result in large fines and criminal prosecution. Fluorescent tubes contain mercury and become hazardous wastes when they no longer work. Mercury poses especially serious hazards to pregnant women and small children..." California EPA

<u>California EPA Fluorescent tubes and bulbs and other mercury-containing lamps – Health Warning:</u>
These types "...Include Fluorescent light tubes and bulbs, high intensity discharge (HID), metal halide, sodium and neon bulbs. These lights contain mercury vapor that may be released to the environment when they are broken. Mercury is a toxic metal that can cause harm to people and animals including nerve damage and birth defects. If mercury is released into the environment it can contaminate the air we breathe and enter streams, rivers and the ocean, where it can contaminate fish that people eat.." (A few contain Arsenic & Lead-old Ballasts may Leak PCBs)
