Dear Mr. Burton,

You have inquired about the number of hardship water service connections the District has installed and how many of the existing service base is committed to allocations.

The District has installed 7 hardship water service connections for individuals and has installed 23 hardship water service connections for Bel Arbres Mutual Water Company for a total of 30 hardship water service connections. There were 135 hardship water service connections authorized by legislation and an additional small number have been approved but not yet installed. I can provide a list of names and addresses for the 7 individual hardship water service connections installed if you need them.

The District has 42 water service connections which serve a total of 315 water service allocations. Enclosed please find a list of names and addresses of those water service connections and the number of allocations committed to each.
